



Territorial Tuition and Education Amounts

Schedule NT(S11)
T1 General – 2015

Only the student must complete this schedule. Use it to:

- calculate your Northwest Territories tuition and education amounts to claim on line 5856 of your Form NT428;
- determine the territorial amount available to transfer to a designated individual; and
- determine the unused territorial amount, if any, available for you to carry forward to a future year.

Only the student attaches a copy of this schedule to his or her return.

Eligible tuition fees paid for 2015 **5914** 2

Education amount for 2015: Use columns B and C of forms T2202A, TL11A, TL11B, and TL11C. Only one claim per month (**maximum 12 months**)

Enter the number of months from column **B** (do not include any month that is also included in column C). $\times \$120 =$ **5916** + 3

Enter the number of months from column **C**. $\times \$400 =$ **5918** + 4

Add lines 2, 3, and 4. **Total 2015 tuition and education amounts** = 5

Add lines 1 and 5. **Total available tuition and education amounts** = 6

Enter the amount of your taxable income from line 260 of your return if it is \$40,484 or less.

If your taxable income is more than \$40,484, enter instead the result of the following calculation: amount from line 38 of your Form NT428 divided by 5.9%.

Total of lines 5804 to 5848 of your Form NT428 - 7

Line 7 minus line 8 (if negative, enter "0") = 8

Unused Northwest Territories tuition and education amounts claimed for 2015: Enter the amount from line 1 or line 9, whichever is **less**. - 9

Line 9 minus line 10 = 10

2015 tuition and education amounts claimed for 2015: Enter the amount from line 5 or line 11, whichever is **less**. + 11

Add lines 10 and 12. **Northwest Territories tuition and education amounts claimed by the student for 2015** = 12

Enter this amount on line 5856 of your Form NT428. = 13

Transfer/Carryforward of unused amount

Amount from line 6 _____ 14

Amount from line 13 - _____ 15

Line 14 minus line 15 **Total unused amount** = _____ 16

If you are transferring an amount to another individual, continue on line 17.

Otherwise, enter the amount from line 16 on line 21.

Enter the amount from line 5. (**maximum \$5,000**) _____ 17

Amount from line 12 - _____ 18

Line 17 minus line 18 (if negative, enter "0") **Maximum transferable** = _____ 19

You can transfer all or part of the amount on line 19 to your spouse or common-law partner, to his or her parent or grandparent, or to your parent or grandparent. To do this, you have to **designate** the individual and **specify the territorial amount** that you are transferring to him or her on your Form T2202A, TL11A, TL11B, or TL11C. Enter the amount on line 20 below.

Note: If you have a spouse or common-law partner, special rules may apply; read line 5856 in the forms book.

Enter the amount you are transferring (cannot be more than line 19). **Territorial amount transferred** **5920** - _____ 20

Line 16 minus line 20 **Unused territorial amount available to carry forward to a future year** = _____ 21

The person claiming the transfer should not attach this schedule to his or her return.

* If you resided in another province or territory on December 31, 2014, enter on line 1 your unused federal tuition, education, and textbook amounts from your 2014 notice of assessment or notice of reassessment.
