## **Pooled Registered Pension Plan Annual Information Return**

The administrator of a pooled registered pension plan (PRPP) must file a Form RC368-CA, *Pooled Registered Pension Plan Annual Information Return*, on or before May 1 of the year following the end of the calendar year, as required by section 213 of the *Income Tax Regulations*.

All questions on the form must be answered unless instructed otherwise. If the return is filed late, filed incorrectly, or if it is not filed at all, the Canada Revenue Agency (CRA) can impose financial penalties under subsections 162(5) or 162(7) of the *Income Tax Act*, and under subsection 147.5(24) of the Act, it can give notice of intent to revoke the registration of the plan.
