



## CONTRIBUTIONS TO A CANDIDATE AT AN ELECTION INFORMATION RETURN

- This return must be completed by each official agent of an officially nominated candidate at an election of a member or members to serve in the House of Commons of Canada, unless the appointment of such agent had been terminated prior to completion of the duties in respect of that particular election.
- Mail the completed return to: Charities Directorate, Canada Revenue Agency, Ottawa ON K1A 0L5, within four months after polling day, or, if applicable, within four months of the date of publication in the *Canada Gazette* of the notice of withdrawal or deemed withdrawal of the writ issued for the electoral district for which the candidate was nominated.
- If you are the official agent or a predecessor official agent, you must keep a copy of each receipt that you signed for income tax purposes. The receipts are for contributions to the candidate during the period covered by this return. You must keep the receipts for two years after the end of the calendar year in which the donations were made, and you must make them available to us if we ask to verify them during that period.
