

Fill out this worksheet if you want to calculate partial claims for the following amounts on Form TD1NL, 2016 Newfoundland and Labrador Personal Tax Credits Return.

Do not give your filled out worksheet to your employer or payer. Keep it for your records.

Line 2 of Form TD1NL – Age amount

If you will be 65 or older on December 31, 2016, and your estimated net income from all sources will be between \$30,790 and \$68,250, calculate your partial claim as follows:

Line 6 of Form TD1NL – Spouse or common-law partner amount

If your spouse or common-law partner's estimated net income for the year (including the income earned before and during the marriage or common-law relationship) will be between \$720 and \$7,912, calculate your partial claim as follows:

Line 1 minus line 2				3
Enter this amount on line 6 of Form TD1NL.	=			

Line 7 of Form TD1NL – Amount for an eligible dependant

If your dependant's estimated net income for the year will be between \$720 and \$7,912, calculate your partial claim as follows:

Your eligible dependant's estimated net income for the year		-		2
Line 1 minus line 2				3
Enter this amount on line 7 of Form TD1NL.	=			

Line 8 of Form TD1NL – Caregiver amount

If your dependant's estimated net income for the year will be between \$13,660 and \$16,455 calculate your partial claim as follows:

Base amount				1
Your dependant's estimated net income for the year		-		2
Line 1 minus line 2 (maximum \$2,795)		=		3
Enter the amount you claimed for this dependant on line 7 of Form TD1NL.		-		4
Line 3 minus line 4				5
Enter this amount on line 8 of Form TD1NL.	=			

Line 9 of Form TD1NL – Amount for infirm dependants age 18 or older

You cannot claim this amount for a dependant for whom you claimed the caregiver amount on line 8 of Form TD1NL. If your dependant's estimated net income for the year will be between \$6,007 and \$8,802, calculate your partial claim as follows:

Your infirm dependant's estimated net income for the year		-		2
Line 1 minus line 2 (maximum \$2,795)		=		3
Enter the amount you claimed on line 7 of Form TD1NL for this dependant.		-		4
